- ix. the expenditure shall commensurate with the physical progress achieved.
- x. all video graphic/photographic evidence of works both shall be maintained;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xii. no expenditure shall be incurred against revised cost which has not been approved by the competent authority.
