The release & subsequent utilization of funds is subject to the following conditions that:-

(i) No payment shall be made for incomplete work/assignments;

(ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;

(iii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

 (iv) the funs shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;

(v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;

(vi) the funds so released shall not be available for any reappropriation/diversion;

(vii) the expenditure shall commensurate with the physical progress achieved;

(viii) all video graphic/photographic evidence of works both shall be maintained.

ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

(x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
