- The Controlling Officers/DDO's shall conduct periodic reconciliation of remittances and drawals with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.

- 7. The Controlling Officers shall strictly inspect and supervise the public receipts and expenditure with reference to all the standing rules and regulations.
