- (viii) the Utilization Certificates/Red Accounts of the amount shall be rendered to the concerned quarters including Accountant General (A&E), J&K within a stipulated
- (ix) the expenditure shall commensurate with the physical progress achieved;
- Accounts/monthly drawal/expenditure statements of the PIO on quarterly basis shall be rendered to the concerned for consolidation latest by the month following close of
- all video graphic/photographic evidence of works both shall be maintained;
