## Government Order No. <u>102</u> -HUD of 2019 Dated 29 .03.2019

In continuation to Govt. Order No. 277-HUD of 2018 dated 20.9.2018, Sanction is hereby accorded to the release of **Rs. 100.50 lacs** (Rupees One crore & Fifty Thousand only) in favour of Mission Director, Housing For All (Mission) as State Matching Share under the scheme PMAY(U) — Housing For All (Urban) , thereby aggregating the total release to the tune of Rs.4.13 crore as state share under Capex Budget during the current financial year 2018-19.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, HFA(U), bearing Account No. **0110010200000870** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further releases to implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i) the implementing agency shall comply with the terms and conditions stipulated in the guidelines, CSMC directions and the instructions issued by the Ministry of HoUA, GoI.
- ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iii) the Director Finance, H&UDD shall vouchsafe the availability of funds.
- the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. etc;
- the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- vii) the funds so released shall not be available for any reappropriation/diversion;
- viii) the implementing agency shall transfer the funds as per the financial pattern in the guidelines of GoI for the programme under HAD(U) and for the specific purposes for which it has been released.



- ix) the expenditure shall commensurate with the physical progress achieved;
- x) all video graphic/photographic evidence of works both shall be maintained.
- the physical and financial progress report alongwith Utilization Certificate and red accounts of the funds released shall be furnished to the concerned quarters including Accountant General (A&E), J&K within stipulated time.
- xii) The State Nodal Officer of HFA shall strictly monitor the progress of the scheme.
