- There should be uniform expenditure under each object head to avoid rush of expenditure 2. during the last quarter of the financial year.
- The controlling officers shall be duty bound to ensure submission of revenue and 3. expenditure statements to this Department on monthly basis.
- DDOs shall comptete all codal formalities before presentation of bills at the Treasury. 4.
- The controlling Officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct 5. reflection of income and expenditure in the Finance and other Accounts.
- The Utilization certificate//Red Accounts of previous drawls have been rendered to the 6. concerned quarter without any delay.
- The controlling Officers shall strictly inspect and supervise the public receipts and expenditure with reference to the Appropriation Act 2019 and all the standing rules and 7. regulations.
- All the sanctions/approvals and clearances shall be in place before drawal of money from 8. the Treasury.
