Sanction is hereby accorded to the release of **Rs.523.58 lacs (Rupees Five Hundred Twenty Three lacs & Fifty Eight thousand only)** as 2nd installment of Central Assistance (CA) for Construction of CT/PT under ODF Component of Swachh Bharat Mission (Urban) during 2018-19.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, Swachh Bharat Mission (Urban) bearing Account No. **0110040500000063** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further releases to implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;

- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) all video graphic/photographic evidence of works both shall be maintained.
- (vii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2018 to GOI, with a copy to Finance Department.


