- the Director Finance, H&UDD shall vouchsafe the utilization of funds as per codar VIII: procedure/guidelines;
- the Utilization Certificate/Red Account of the amount shall be rendered to the ix. concerned quarters within a stipulated time;
- the expenditure shall commensurate with the physical progress achieved; Χ.
- the physical and financial progress report shall be furnished to the Admin. Deptt. Χİ. well in time, i.e. 5th of succeeding month;
- all video graphic/photographic evidence of works both shall be maintained; XII.
