In continuation to Govt. Order No. 182-HUD of 2018 dated 14.06.2018, sanction is accorded to the release of funds to the tune of Rs. 100.00 Lacs (Rupees Hundred Lakh) only Rs. 50.00 lacs each in favour of Superintending Engineer, Drainage circle, JMC/SMC under State Capex Budget 2018-19 for its further placement at the disposal of concerned Executive Engineers to be utilized for execution of approved ongoing schemes/works under Drainage Sector during current financial year 2018-19.

The release & subsequent utilization of funds is subject to the following conditions that;

- the funds be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance of the Govt. order and copy endorsed to the Administrative Department;
- the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority and no funds shall be available for utilization for those schemes/works which have been approved under languishing project;
- (v) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (vii) the implementing agency shall ensure that the funds shall be utilized only after submission/approval of Action Plan/Works Programme 2018-19. Besides, the funds so released shall not be available for any re- appropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) all video graphic/photographic evidence of works both shall be maintained;



- the physical and financial progress report shall be furnished to the Admn.
   Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
