- 2. No diversion/re-appropriation of funds so released is allowed.
- 3. The released funds does not confer the sanction for incur the expenditure which shall be booked after observing all codal formalities.
- 4. The funds shall be utilized for implementation of scheme strictly as per originally approved components and accordingly to Govt. of India's prescribed guidelines.
- 5. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- 6. The Department shall send utilization certificates of the funds released as early as possible.
- 7. The Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
