The release & subsequent utilization of funds is subject to the following conditions that: -

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- ii. As regards to Land Compensation, the VC LAWDA shall ensure that the Land Acquisition cases shall be disbursed to the land owner after actual assessment as per the final award issued by the Revenue Authority and proper confirmation of title of land;
- the funds so released shall be utilized for the activities specifically provision for; after completion of all the codal formalities/procedures as required under rules and shall not be available for re-appropriation/diversion at any level, besides the expenditure shall not be utilized on Revenue or Revenue like items;
- iv. the vetted cost of each component/activity shall not be exceed in any case and all the necessary clearances/approvals shall be sought from the competent/regulatory Authority before implementation of the scheme;
- V. Drawing and Disbursing Officers shall satisfied themselves about the responsibilities of cost, proper quality control, genuineness of workdone claims and physical existence of works;
- vi. the implementing agency shall ensure that, reasonability of rates and complete the project within the approved cost only and there should be no cost overrun/time overrun;
- vii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;



- VIII. the Director Finance, H&UDD shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- ix. the Utilization Certificate/Red Account of the amount is rendered to the concerned quarters within a stipulated time;
- X. the expenditure shall commensurate with the physical progress achieved;
- the physical and financial progress report shall be furnished to the Admin. Deptt. well in time, i.e. 5th of succeeding month;
- xii. all video graphic/photographic evidence of works both shall be maintained;
