- the funds be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance of the Govt. order and copy endorsed to the Administrative Department
- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall not be utilized on clearance of any past liability, repair, renovation and maintenance work and there shall be no expenditure on Revenue or Revenue like items;
- iv. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- v. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the expenditure shall commensurate with the physical progress achieved;

- viii. all video graphic/photographic evidence of works both shall be maintained.
- ix. the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- x. all codal formalities are strictly adhered to while booking the expenditure;
- xi. the Administrator/Executive Officer MC, Kargil/Leh shall ensure the submission of physical and financial progress report to the Administrator Department well in time.

In respect of Street Lighting components following conditions be adhered to:

- The funds shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- b. The funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates after following all codal formalities under rules, simultaneously, functioning of all defunct lights be ensured;
- c. The warranty clause of 24 months from the date of installation shall be incorporated in the allotment of the contract;
