Subject:- Release of Rs.420.00 lacs as Reform incentive to Govt. of J&K under AMRUT for the year 2018-19.

Sanction is hereby accorded to the release of **Rs.420.00 lacs** (**Rupees Four Hundred Twenty lacs only**) as Reform incentive to Govt. of J&K under AMRUT for the year 2018-19 in favour of Mission Director, AMRUT for its utilization during 2018-19.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, AMRUT bearing Account No. **0110040500000061** maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for further releases to implementing agencies.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) The incentive fund is an additionally and no matching funds will be required to be given by the State Govt/ULBs.
- (ii) The State High Power Committee (SHPSC) will decide the use of the incentive amount. The incentive award will only be used in Mission Cities on admissible components of the AMRUT, including new projects. However, the SHPSC will inform the MoHUA, GoI of the use of incentive funds on projects
- (iii) The incentive cannot be used as the State Share in project in the AMRUT but can be used by the ULBs for their project funding.
- (iv) Unutilized funds for Reform incentive will be transferred to project Fund every year
- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (vi) the funds shall be utilized for the purpose for which it has been released and diversion of Central Grants for purpose other than the Mission projects is not allowed.



- (vii) The funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- (viii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (ix) the funds so released shall not be available for any reappropriation/diversion;
- the expenditure shall commensurate with the physical progress achieved;
- (xi) all video graphic/photographic evidence of works both shall be maintained.
- (xii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2019 to GOI, with a copy to Finance Department.
