Consequent upon the approval of State Administrative Council Decision No. referred to above, sanction is hereby accorded to Change in nomenclature of M/s Highland Automobiles Pvt. Ltd; joint venture in consortium with Key Stone Energy System LLP and Astrix Infra Pvt. Ltd; to M/s Syntech Bioenergy Pvt. Ltd, a Special Purpose Vehicle (SPV) jointly created between Highland Automobiles Pvt. Ltd created and registered before the Registrar of Companies, Ministry of Corporate Affairs, Govt. of India in respect of Waste to Energy Plant at Achan, Saidapora Srinagar.

M/s Syntech Bioenergy Pvt. Ltd, a Special Purpose Vehicle (SPV) shall henceforth execute the:-

- (a) power purchase agreement with Housing & Urban Development Department; and
- (b) concession agreement with Srinagar Municipal Corporation.
