Sanction is hereby accorded to the revalidation of funds amounting to **Rs. 197.592 Lakh (Rupees One Core, Ninety Seven Lakh, Fifty Nine Thousand, Two Hundred only)** in favour of **Administrative Secretary, Ladakh Affairs Department for its further placement to Deputy Commissioner/CEO, LAHDC Leh for Capital creation under RAY projects subsumed in PMAY(U)** to be utilized for "Pilot Projects for in-situ Up-gradation of 5 slums in Leh Town" during current financial year 2019-20 as per the approved components of the DPR by Govt. of India.

However, further release of funds shall be subject to fulfilment of the following conditions:-

- i. the release of funds does not confer the sanction to incur the expenditure which shall be booked only after observing all codal formalities;
- ii. no diversion/re-appropriation of funds so released is allowed;
- iii. the funds shall be utilized for implementation of scheme strictly as per originally approved components and according to Govt. Of India's prescribed guidelines;
- iv. the progress report about the scheme, in terms of physical and financial progress achieve during the current year and upto date cumulative expenditure and physical achievements be furnished to this department regularly;
- v. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- vi. the implementing agency shall furnish the utilization certificates of the released funds;
- vii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- viii. all video graphic/photographic evidence of works both shall be maintained.
- ix. the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;


