the vetted cost of each component/activity shall not be exceed in any case and all the necessary clearances/approvals shall be sought from the competent/regulatory Authority before implementation of the scheme;

- Drawing and Disbursing Officers shall satisfied themselves about the responsibilities of cost, proper quality control, genuineness of workdone claims and physical existence of works, besides ensure that no payments shall be made for incomplete work/assignments;
- V. the implementing agency shall ensure that, reasonability of rates and complete the project within the approved cost only and there should be no cost overrun/time overrun;

- vi. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- viii. All video graphic/photographic evidence of works both shall be maintained;
- ix. The physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
