

Subject: -Release of funds as capital grant-in aid under Central Sponsored Scheme (SJSRY) during the Current financial year 2013-14.

Sanction is hereby accorded to the withdrawal of funds amounting to Rs.76.08 lacs (Rupees Seventy Six Lacs and Eight Thousand only) from the official account No: - 5976 favouring J&K SUDA and placement of the same at the Disposal of District Urban Development Agencies of the State as capital part of Grant-in aid (Central share) under Urban Self Employment Programme (USEP)/Urban Women Self Employment Programme (UWSP) components of SJSRY as subsidy for loan cases sanctioned by the Banks/Financial Institutions during the current financial year 2013-14. However, the release of funds is subject to the following conditions;-

- i. The release of funds does not confer the sanction to incure the expenditure and shall be booked only after observing all codal formalities.
- ii. The saving if any shall not be re-appropriated towards any other component without the approval of the competent authority,

- iii. The implementing agency shall ensure that there is no overlapping of funds for the cases sanctioned by the financial institutions.
- iv. The expenditure shall commensurate with the physical progress achieved.
- v. The DUDA's shall furnish physical/financial progress report to this department on monthly basis as per the subsidy released to the banks/financial institutions.
- vi. The utilization certificate of the funds so released shall be furnished to this department expeditiously by 31th of March 2014.
- vii. The interest money (if any) accrued on previous funds during the parking in the Bank Account shall not be utilized without the approval of Administrative Department.

Any deviation in non fulfilment of aforementioned conditions shall be treated as misappropriation of funds.
