CIRCULAR

Ease of Doing Business - Documents required for Trade Subject: License/ Renewal thereof.

In terms of SRO-247 dated 19-07-2011, among other services, Trade License and Renewal thereof, was notified under Jammu and Kashmir Public Services Guarantee Act, 2011 with timelines and the Designated Officers / Appellate Authorities. For the said purposes, minimum three documents obtained at the time of apply by any applicant for issuance of Trade License.

Now, to simplify the procedure for obtaining the Trade License (NOC for Commercial Establishment) for commercial/industrial/Citizens use by firm/ company and commercial establishment and as per the practice of other States/UTs in this regard, it is hereby ordered that the following two documents need to be attached with the application form henceforth:

- Legal occupancy / land document of the premises that 1. includes a copy of the document given below:
 - a) Commercial building permission
 - b) Site plan
 - c) Parking plan
 - d) Lease deed or rent deed of the applicant/firm/company. (If applicable)
- 11. Proof of identity:
 - i. Where the applicant is an individual (any one of the documents given below)
 - a) Electoral Identity Card
 - b) Passport
 - c) Driving license

- d) Ration card
- e) Photo identity card issued by a government agency
- f) PAN card
- g) Aadhar Card
- ii. Where the applicant is a firm company the letter of authorization/application form shall be signed by the authorized person. In the case of a registered company, all the directors shall be jointly and separately liable.
- iii. Public notification in the newspaper.

It is further ordered that an Auto Renewal of Trade license is to be implemented forthwith, subject to inspection report from the concerned authority, which is pre-requisite document for the said purpose.
