Jammu, the 27/4 of April, 2007.

SRO/70 In exercise of the powers conferred by section 35 of the Jammu and Kashmir Municipal Corporation Act, 2000, the Government hereby make the following amendments to the Jammu and Kashmir Municipal Corporation (Allowances to Councillors) Rules, 2005:-

I. After Rule 2, the following shall be inserted, namely:-

"2-A. Honorarium to Councillors.- The Councillors shall be paid an honorarium of Rs.6000/- per month".

II. In rule 3,-

- (a) the word and figures "Rs.300/-" shall be substituted by word and figure "Rs.400/-"; and
- (b) after the words "Standing Committees" the words "subject to five sittings per month" shall be inserted.

This notification shall be deemed to have come into force w.e.f. 1st of April, 2007.

SRO 171 In exercise of the powers conferred by sub-section (4) of section 13 and sub-section (3) of section 24 of the Jammu and Kashmir Municipal Act, 2000, the Government hereby make the following amendments to the Jammu and Kashmir Municipality (Allowances to Members, President and Vice-President) Rules, 2005:-

- I. In rule 3,-
 - (a) the words and figures "Rs.100/-" and "Rs.50/-" shall be substituted by the words and figures "Rs.300/-" and "Rs.150/-" respectively; and
 - (b) after the words "Standing Committees" the words "subject to five sittings per month" shall be inserted.
- II. In rule 4, the words and figures "Rs.2500/-" and "Rs.1500/-" shall be substituted by the words and figures "Rs.5500/-" and "Rs.4500/-" respectively.
- III. Rule 5 shall be recast as under:-

"5. Honorarium to Vice President. - The Vice-President of the Municipal Council and Municipal Committee shall be paid an honorarium of Rs.3500/- and Rs.3000/- per moth respectively, besides the usual allowance as Member."
- IV. After the rule 5, the following shall be inserted, namely:-

"5-A. Honorarium to Members of the Municipal Council and Municipal Committee. - The Members of the Municipal Council and Municipal Committee shall be paid an honorarium of Rs.2500/- and Rs.2000/- per month respectively".

The amended rules shall be deemed to have come into force w.e.f. 1st of April, 2007.
