- 1.2.12 Microbes present in the product should non-pathogenic (should not be a cause of disease) to humans, animals and plants and considered as *GRAS* (Generally Recognized As Safe)
- 1.2.13 Microbes should be tested and proven under wide range of environment conditions
- 1.2.14 Microbes should possess versatile broad-spectrum action
- 1.2.15 Microbes should have easy application process
- 1.2.16 Microbes should be highly stable

1.3 Eligibility Criteria for the Company (to declare responsive bid and evaluate further)

- 1.3.1 The bidder is defined as a company registered under the Indian Companies Act, 1956, or a joint venture of such Indian companies or a consortium of Indian companies
- 1.3.2 A consortium will be a group of companies having a lead partner wherein each partner of the consortium is jointly and severally responsible / liable for the bid and the performance of the contract and this liability has been formalised and secured through an MOU. The bid shall be submitted by the lead partner of the consortium as per the guidelines along with a copy of the MOU(s)
- 1.3.3 The bidder shall submit its application in duplicate in the prescribed application form
- 1.3.4 The bidder shall pay a non-refundable application fee of Rs 5,000/- in the form of Demand Draft and EMD of Rs. 1.00 lac drawn on any Scheduled Bank payable at Jammu in favour of "Mission Director AMRUT" Civil Secretariat, Jammu
- 1.3.5 Bidder should be a manufacturer of the products. In case of JV or consortium, ANY ONE company should be manufacturer of the products.
- 1.3.6 The lead bidder company should have minimum turnover of Rs.5 Crore in the year 2014-15. This should be supported by audited balance sheet for the year 2014-15.

1.2 Scope for Work

Area of application through bioremediation

<u>Pollution \</u> be able to degrade organic pollutants and control algal bloom to maintain the natural ecological equilibrium of the water bodies

Pollution control in nallahs and drainages

The microbes should be able to degrade organic sludge and control odour from free-flowing nallahs and drainages

Pollution control in Sewage Treatment Plant

The microbes should be able to control pollution parameters like COD, BOD, Ammoniacal Nitrogen etc and degrade sludge

Septage Control in Septic Tank and Soak Pit

The microbes should be able to reduce sludge and prevent clogs from plumbing outlets, septic tanks, soak pits etc

1.5 Other Terms & Conditions/Requirements

- 1.5.1 For interpretation of any clause of this tender, the decision of <u>Mission Director AMRUT/H&UDD</u> would be final and binding on the bidder
- 1.5.2 The bidder and all its substantial equity holders, consortium and all its members would be jointly and severally responsible for supply of bioremediation products
- 1.5.3 The supply of product will be executed within three months from the issue of contract and advance. Thereafter, procedure would be conducted from time to time within a period of three (3) years as per need and depending upon the requirement of department

1.6 Procedure for Submission of Bids

- 1.6.1 The bid shall be evaluated in 3 stages viz. eligibility, technical and financial. The bid therefore, shall comprise of the following documents:
 - **1.** A covering letter in duplicate detailing the eligibility criteria as mentioned in Para 1.3 above along with supporting documents, application Fee as per para 1.3
 - 2. Technical bid in duplicate as per Annexure II A of this TENDER, wax sealed in a separate envelope and complete in all respects with supporting documents and clearly marked as "TECHNICAL BID" on the envelope.
 - **3.** Financial bid in duplicate as per Annexure II B of this TENDER, valid for 3 years, wax sealed in a separate

envelope and complete in all respects and clearly marked as "FINANCIAL BID" on the envelope.

All the above three documents shall be kept in a wax sealed cover. This cover shall bear the submission address, and clearly marked "Bid for Selection of Agency for <u>"Rate Contract of Bioremediation Products"</u>

- 1.6.2 In the "FINANCIAL BID", the bidder shall quote its rate item wise which shall clearly define rates applicable for the duration of 3 years from the date of award of contract. The rates in the rate contract will remain constant for 3 years.
- 1.6.3 The 4 items mentioned for rate contract can be contracted to different suppliers based on L1 arrived at after the tenders are finalized. It is also possible that the same supplier may be able to achieve L1 for all the products.

1.7Time Schedule and Clarification of TENDER Documents, Pre-bid Conference and Submission of Offer

- 1.7.1 Any bidder interested for providing Bioremediation Products should respond to this TENDER as per Calender of Events enclosed at Annexure III to this TENDER, to Mission Director AMRUT/Commissioner/Secy. to Govt. H&UDD, Civil Sectt. Jammu.
- 1.7.2 A pre-bid conference will be held at 11.00 the office chambers 17.02.2016 in of Mission AMRUT/Commissioner/Secretary to Govt. H&UDD. Room No. 3/25, Mini Block, Civil Secretariat, Jammu with prospective bidders. Based on the feedback received, responses to the clarifications sought shall be sent to all prospective bidders. Should the Housing & Urban Dev. Department deem it necessary to amend the TENDER, it shall do so following the procedure under para. 1.10.4 below
- request a clarification 1.7.3 Prospective bidders may clause of the TENDER documents up to 19.02.2016. Any request for clarification must be sent in writing, or standard electronic means to the address indicated in the Calender of Events. The H&UDD will respond in writing, or by standard electronic means. Should the H&UDD necessary to amend the TENDER as а result of а clarification, it shall do so following the procedure under para. 1.8.4 below.

- 1.7.4 At any time before the submission of bids, the Department Housing and Urban Development of may amend the TENDER by issuing an addendum in writing or by standard electronic means. addendum shall The be sent to all prospective bidders and will be bindina on them. Prospective of bidders shall acknowledge receipt all amendments.
- 1.7.5 The time schedule for other activities shall be as per Annexure III.

1.8 Selection criteria

- 1.8.1 All bidders shall submit documentary proof in support of meeting eligibility criteria as laid down in para 1.3. In the first stage of evaluation, a Proposal shall be rejected if it is found deficient as per the requirements of Tender Fee/Bid Processing Fee/ eligibility for responsiveness of the proposal. Only responsive bids shall be further taken up for financial evaluation.
- 1.8.2 Evaluation of the technical Bid will start for responsive bids only and at this stage the financial bid (proposal) will remain unopened. The Financial bids of all eligible bidders shall be opened on the same day before the bidders or their authorized representative(s).
- 1.8.3 The evaluation criterion is provided in the Annexure IIA item 11 and only those bidders scoring 50 marks out of 100 or above on the criteria mentioned shall be eligible for opening of financial bid.
- 1.8.4 Those declared technically qualified, only their financial bids will be opened for further evaluation. The financial bids of the remaining bidders shall be returned in unopened condition. The successful eligible and technically qualified bidder(s) shall be intimated through FAX and/or e-mail.
- 1.8.5 The final selection will be made on the basis of the combined score in technical and financial criteria Item wise. For this purpose a weightage of 60 marks have been assigned in Annexure IIA item 40 marks will be assigned to financial quote item wise.
- 1.8.6 The lowest financial bid will be assigned the full weightage and the rest will be proportionately given lower weightages as per the formula (Lowest price/ Quoted price) x 40 The item wise

- weighted scores of technical and financial criteria will be added up and the bidder with the highest combined score will be declared successful for that item.
- 1.8.7 In situations where lowest quoted rate (L1) of two or more technically qualified bidders are the same, a fresh round of financial bids from such bidders shall be called for that item only. The bidder with the lowest valid offer among these shall be selected.

1.9 Bid Validity

1.9.1 Bids must remain valid for 150 days after the submission date. Should the need arise, however, bidders may be requested to extend the validity period of their bids. Bidders who agree to such extension shall confirm that their financial bid remains unchanged.

1.10 Payment Terms

- 98% of payment will be made within 10 days of supply of material. 2% will be retained as security against short supply or ineffective product.
- The 2% security will be released after 3 months after satisfaction of the user agency is ascertained.

1.11 Department's Rights in respect of TENDER

- 1.11.1 Department of Housing and Urban Development reserves the right to accept or reject any bid without assigning any reason.
- 1.11.2 Department of Housing and Urban Development reserves the right to modify terms and conditions of the contract which shall be granted to the successful bidder after the bidding process, if in the opinion of the Department of Housing and Urban Development, it is necessary or expedient to do so in public interest or interest of the environment of the State or for proper conduct of Bioremediation Process. The decision of the Department of Housing and Urban Development shall be final and binding in this regard.
- 1.11.3 Department of Housing and Urban Development reserves the right to suspend and/or cancel the contract with the selected party in part or in whole at any time if in the opinion of the Department of Housing and Urban Development it is necessary or expedient in the public interest.

1.11.4 The decision of the Department of Housing and Urban Development shall be final and binding in this regard. Also Department of Housing and Urban Development shall not be responsible for any damage or loss caused or arising out of aforesaid action.

1.12 Award of Contract

- 1.12.1 Item wise Letter of Intent (LoI) issue to the selected Bidder of item wise.
- 1.12.2 The selected bidder will sign the contract after fulfilling all the formalities/pre-conditions mentioned in the Letter of Intent, within 7 days of issuance of the Letter of Intent.
- 1.12.3 The selected bidder shall commence the assignment on receipt of Lol and as per schedule given to him.

1.13 Security Conditions

1.13.1 The company shall take adequate and timely measures to ensure that information provided through it as part of this contract/agreement shall be kept confidential, secure and protected.

1.14 Force - Majeure

1.14.1 If at any time, during the continuance of this contract, the performance in whole or in part, by either party, of any obligation under this is prevented or delayed, reason of war, or hostility, acts of the public enemy, civic commotion. sabotage, Act of State or direction Statutory Authority, explosion, epidemic, quarantine restriction, and lockouts (as are not limited establishments and facilities of the contractor), fire, floods, natural calamities or any act of GOD (hereinafter referred to as EVENT), provided notice of happenings of any such EVENT is given by the affected party to the other, within 21 Calender days from the date of occurrence thereof, neither party shall, by reason of such event, be entitled to terminate the this contract, nor shall either party have any such claims for damages against the other, in respect of such non-performance or delay in performance provided the contract shall be resumed as soon as practicable, after such EVENT comes to an end or ceases to exist. The of the Administrative Secretary, Department Housing and Urban Development as to whether the contract

may be so resumed (and the time frame within which the contract may be resumed) or not. shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a exceeding 60 days either party may, at his option terminate the contract.

1.15 Arbitration

- 1.15.1 In the event of any question, dispute or difference arising under the agreement in connection therewith (except as to matters, the decision to which is specifically provided under the same shall be referred agreement) arbitration of the Administrative Secretary, Department of Housing and Urban Development (hereinafter referred to as the said officer) and if the Secretary, Department of Housing and Urban Development is unable or unwilling to act as such, than to the sole arbitration of some other person appointed by the Secretary, Department of Housing and Urban Development.
- 1.15.2 The venue of the arbitration proceeding shall be the office of Secretary, Department of Housing and Urban Development or such other place as the arbitrator may decide.
