Subject: - Engagement of NGO's/Trust/Foundations/contractors for construction of Individual Household Latrines under Swachh Bharat Mission.

Ref: - Expression of Interest No HUD/Plan/C.Toilets/28/2015-II dated 01/09/2017

Whereas against Expression of Interest invited by the department vide No. HUD/Plan/264/2015, Dated 20/02/2016 for the construction, commissioning of Individual Household latrines under Swachh Bharat Mission in urban areas of J&K, strictly as per the specifications mentioned in the guidelines of SBM, 17 (Seventeen) NGO's/Trust/Foundations/contractors who were found technically qualified were empanelled for the job vide Office Order No 38 HUD of 2016 dated 16.03.2016 on lowest quoted rates of **Rs.17,490/- (Rupees Seventeen thousand Four hundred and Ninety only)** for construction of Individual Household Latrines by way of P.C.C (Plain cement concrete)/ masonry structure and **Rs.16,540/- (Rupees Sixteen thousand five hundred and forty only)** for construction of Individual Household Latrines by way of FRP (Fiber reinforced plastic) structures.

Whereas fresh Expression of Interest was invited by the department vide No. HUD/Plan/C.Toilets/28/2015-II dated 01/09/2017 to empanel more agencies to accelerate the Construction, Commissioning of Individual Household latrines under Swachh Bharat Mission in urban areas of J&K, on the already approved lowest rates in terms of Office order No: 38 HUD of 2016 dated 16.03.2016 and as per the specifications mentioned in the guidelines of SBM.

Whereas in-response to fresh EoI, out of 22 NGO's/Trust/ Foundations/ contractors who have expressed their interest in the job, only 19 following agencies were found eligible on technical evaluation of documents as required in terms of EoI for construction of Individual Household Latrines under Swachh Bharat Mission (U):-

Therefore all the above mentioned 19 (Nineteen) NGO/ Trust/ Foundation/ Contractor eligible for job have been approved for their empanelment, so that they can be engaged for construction of Individual Household Latrines, with maximum number of units to be allotted restricted to 100 in each Corporation/ ULB's in a single order at the approved cost shown against each:-

The engagement /empanelment is subject to the following conditions:-

- I. All the terms and conditions as mentioned in the Expression of Interest shall remain in force.



- II. The construction shall be closely monitored by the Engineering staff of the concerned ULB to ensure that execution of work is done as per approved design, specifications mentioned in the guidelines of Swachh Bharat Mission.
- III. The agency shall construct the toilets within reasonable time frame to be decided by concerned corporation/ ULB from the date of issuance of engagement order.
- IV. The payment shall be made in stages only after the completion certificate duly signed by the concerned beneficiary is furnished.
- V. Any addition/ modification if any to be made in type design in view of site condition shall subject to approval of Executive Engineer concerned
- VI. The Director Urban local Bodies Jammu/Kashmir & Commissioner SMC/JMC or their subordinate agencies shall draw necessary agreement with the executing firm/ NGO before the start of work.
- VII. The concerned Corporation/ ULB's shall upload the photographs of the completed IHHL along with beneficiary picture.
- VIII. The concerned Corporation/ ULB's shall provide the list of beneficiaries in those cases where the IHHL's are to be constructed by the approved NGO/ Firms.
