CIRCULAR

Subject: Procurements through GeM/e-Tender Portal- Instructions thereof

Finance Department vide Government Order No: 162-FD of 2018 dated 28.03.2018 has ordered that all departments shall compulsorily tender all works/procurements costing more than Rs 1.00 Lakh (Rs one Lakh Only) through e-tendering. Vide Circular No. FD-Code/24/2022-03-418 dated 23-02.2022 and other circulars issued by Finance Department from time to time instructions in respect of Procurements through GeM have been issued. Further, Rule 149 of the GFR-2017 provides that it is mandatory for the Government Departments to purchase goods and services through GeM (Government-e-Marketplace) portal.

It has been brought to the notice of this department that departments under the administrative control of H&UDD are not following these instructions/guidelines properly and are making procurements through local tenders without inviting e-tenders in violation of rule. The matter has been viewed seriously by the authorities.

It is accordingly impressed upon all the HOD/ DDO under the administrative control of H&UDD to strictly adhere to the instructions issued on the subject and ensure that all the procurements are being made either through GeM (Government-e-Marketplace) portal or through e-tendering portals.

A list of all the works done/under process in violation of these guidelines at the Directorate/ District level needs to be send by all HODs within a week's time positively, along with the names of the officers responsible.
