Consequent upon the decision taken by the committee constituted vide order referred to above in a meeting held on 21<sup>st</sup> November '2017 and after verification of certificates of accreditation, sanction is hereby accorded for the empanelment of below mentioned thirty one (31) Skill Training Providers (STPs) who had applied against Expression of Interest (EoI) vide endorsement No: HUD/PLAN/ESTT&P/2017/16; Dated:06-04-2017 issued by SUDA and Expression of Interest (EoI) issued vide Notification No:03 & 04 HUD of 2017 Dated:20-07-2017 & 30-08-2017 respectively under EST&P Component of National Urban Livelihood Mission (NULM) and found eligible in terms of conditions as laid down in EOI as per guidelines of MoHUPA, GoI.

**The empanelment of Skill Training Providers shall be subject to the fulfilment of following terms and conditions:**

- Chief Executive Officers JUDA/UDAK and all Project officers of District Urban Development Agencies shall undertake the physical verification of these institutes to ascertain/ certify that the basic requirement of infrastructural facilities , availability of recourse persons and also verify original registration certificates of registering agencies (NSDC/PMKVY/SSC) before sponsoring of eligible candidates against potential trades.
- As per the decisions of State Level Executive Committee meeting of DAY-NULM held on 26<sup>th</sup> December' 2017 under the chairmanship of worthy Chief Secretary, J&K, sponsoring of candidates should be made under potential trades having huge employability potential like Construction workers like Masoning, IT,GST training under Banking & Accounting, Health care attendants etc. The sponsoring in Cutting & Tailoring trade shall be discouraged as same is already being promoted by other departments like Social welfare, Industries & Commerce, KVIB etc.In the recent review meeting of DAY-NULM,




held on 15-03-2018 under the chairmanship of Financial Commissioner, H&UDD, cutting and tailoring trade including garment designing should be discouraged and sponsoring and thrust should be put on the trades like I.T (e-commerce), Logistics including packaging, Apiculture, Health care, Food & Allied Sector.

- iii. The sponsoring shall be made within physical targets under EST&P component for 2017-18 for each town already communicated to the UDAK/JUDA and DUDA's only to the above mentioned empanelled institute **strictly before 20<sup>th</sup> March 2018 without fail** to achieve the targets in full under the said component in the respective district/town that too after seeking a prior approval of the Chairman of the concerned District Urban Development Agency.
- iv. The Payment shall be paid strictly as per the guidelines of MoHUPA; GoI in vogue to Skill Training Provider up to 80% and remaining 20% shall be disbursed after successful placement of respective batches of the training and submission of all relevant reports and issue of certification in support of the same, from the designated officer of the concerned DUDA.
- v. Respective DUDA's will enter into an agreement with the Skill Training Provider (STP) to clearly specifying that STP satisfies all terms and conditions as laid down in the EoI. The courses offered are NSQF compliant and placement linked as per the guidelines of EST&P component of DAY-NULM in vogue. Any violation if found during the course of training upto certification and thereafter placement stage would be liable to deduction of course fee of respective STP.
- vi. In order to oversee the quality of training imparted by STP, the regular inspection of STP's shall be conducted by respective DUDA's.
- vii. The sponsoring of candidates should not be merely for achievement of targets but potential trades with placement records in the market be identified in the first instance and thereafter candidates be mobilized to adopt those trades so that the objective of scheme is purposefully achieved.
- viii. The empanelled Institute shall be disqualified at any stage, on account of furnishing any false information which shall be deemed sufficient proof/evidence for its disqualification.
- ix. The Empanelment will be valid initially for one year i.e. for the financial year 2017-18 and will be extended to the next financial year, subject to the performance of the Institute in respect of successful training and placement assistance to the candidates.
- x. The Institute shall submit a copy of NSQF complaint course curriculum of approved trade/trades to be undertaken under skill training in advance to the concerned Project Officer of District Urban Development Agency (DUDA). Besides, Institute shall also furnish the time schedule of commencement of training batch in advance to the concerned DUDA. Any change in time schedule shall be affected by prior approval of the Project Officer of concerned DUDA, under intimation to the State Mission Management Unit(S.M.M.U.)
- xi. Mere Line of activity approved by surveying officials does not in any way signify the allotment of candidates on approved trades. SUDA/DUDA reserves a right to sponsor candidates for trades having recognized/valid certification under NSDC/SSC/PMKVY, huge entrepreneurial potential or high job demand in Public/Private Sector.
- xii. The Empanelled institutes shall have to maintain the Biometric/Online attendance of the sponsored candidates through NULM MIS.
- xiii. SUDA reserves the rights to disqualify any of the empanelled Institute from the list if the performance of the same is found to be unsatisfactory during the period of empanelment and forfeit all claims if any.



- xiv. All other terms and conditions as mentioned in the Expression of Interest issued vide No: HUD/PLAN/EST&P/2017/16; Dated: 06-04-2017 and Expression of Interest (EoI) issued vide Notification No: 03 & 04 HUD of 2017 Dated: 20-07-2017 & 30-08-2017 shall strictly be complied.
